BVF Ranking system proposal – Beth Davidson

To use a system which is similar to England Fencing's youth events

4.1 The ranking list co-ordinators will assign points according to the final position achieved in the competition. (See point 5)

4.2 Points are only awarded to fencers finishing in the top 50% of the competition and only if they finish in the L32. This will be rounded down of the 50% calculation. ***(This could be taken out for Veterans due to low numbers)***

4.3 The BEST 5 results count for your England Ranking.

5) HOW POINTS WILL BE CALCULATED

The points for a competition are calculated by multiplying

(Number of fencers in competition) x (Age group multiplier) x (Position multiplier) -

The Number of fencers in the competition speaks for itself but for the elimination of doubt this will include any starter who has to abandon or is removed from the competition for disciplinary reasons.

The Age group multipliers will be 1 for U12+U13 competitions; 2 for U14 and U15 competitions; 3 for U16 competitions and 4.5 for U17 competitions. ***(Age group multipliers could be an interesting concept if we have a mixed age group competitions such as the Nationals and higher categories could get a slightly higher multipliers in a combined age ranking?)***

N.B. A further multiplier of 1.2 will be applied to those competing at the 2019 EYCs (*Extra multipliers could be used for selected international events to indicate a potential greater strength of international events- EVF and European individuals*)

The conventional position multipliers that we use at Senior comps are designed to spread over 64 places and are not ideal for a system that only gives points for a L32, or for comps with only 15 or 20 entries. We have used a different multiplier as follows:

Note that there are steps in the position multiplier table at 3rd/5th, 8th/9th and 16th/17th rewarding the fencer who succeeds in winning more DE fights. The effect of this is that a fencer might earn more points for a 12th place in a large competition like the BYC U14 than they would by coming 3rd in a relatively small LPJS.

The issue for me is the current veteran ranking system is awarding equal or similar points for a podium at the European Championships and getting a podium at a BVF event of 4 people. Awarding 50 points for winning the European Championships as top British and awarding 43 points for finishing in the 128 of the European Championships but 2nd British is disproportionate to the performances.

As this document says <http://www.veterans-fencing.co.uk/documents/ranking%20system%20-%20jrm-vn16.pdf> there is an aspiration to use the ranking scheme for selection of teams but it is biasing those who can afford to attend lots of weaker competitions over those who perform well at harder competitions. This is not the basis to select the strongest team to challenge for medals in the European and World Championships.

IFO Report 26/1/20

The major event during the period was the International 6 weapon event held at Guildford. This was a very successful event that is reported elsewhere.

The venue has been booked for next year 9th -10th January 2021 and for 8th 9th in 2022.

Next year Cambridge will be on 2nd-3rd so there will not be a clash, and probably we will coincide with Aldershott, so will make sure that the weapons are on opposite days of the weekend.

For the foil and sabre I would like to consider running the competitions as a 60 and over, and a 40 to 59 competition. The poules and DE would be handicapped on an age group basis.

The selection scheme for the Worlds and Europeans has been agreed and published by the committee.

BVF International Guildford

The Event

The competition was held at the Guildford sports centre, where we had a large stadium with ample room for 16 pistes including tiered seats for the finals.

The venue was very good with a good atmosphere and a very friendly staff, in particular Jen, the manager could not have been more helpful.

We had over 100 foreign entries, nearly all at epee. The epee event on Saturday was very full and only finished at 8pm, with little room for warm up. There were significantly more foreign fencers in the Cat1 epee than British fencers, an indication that we are not attracting our younger fencers.

On the Sunday the foil and sabre events had plenty of space, with some of the categories having very small entries

I emailed all the foreign entries after the event and the feedback was very positive. With particular comments on the high standard of refereeing and organisation. There was a small preference for holding the competition on the 3rd January next season.

Collecting entry fees on the day was somewhat problematic, and some confusion was caused by the total for 2 weapons (£70) was the same as the late entry fee for 1 weapon. The late entry fee system brought in a considerable increase in entry income.

Accounts for the event have not been finalised, but we made a very significant profit.

Next Season

For next year we will hire the second hall which will give 3-4 more pistes and a warmup area.

Entry to the hall will be restricted so that the entry doors do not open immediately on to the pistes.

Entries for foil and sabre from Europe should be encouraged, perhaps offering prize money?

The competition will be held on the 2nd weekend in January.

I propose to ask Alex Savin and Mavis Thornton to run the competition again.

There are ways of transferring money from abroad with little or no extra cost. I would suggest that we use a system such as is available on facebook. If we do take cash on the day there should be a surcharge.

Domestic Fencing Officer. Report

LEW

A European team selection season means that we have to pack in all three selection competitions into the first quarter of that year. This brings its own pressures to the calendar and event managers. I'm pleased to report that the first of the three, the international organised by Graham Paul was a great success, well organised with a good team of referees/ DT personnel and Armourer team. All members that competed had a great day fencing. That was both value for money and competitive. The next competition in Feb is the Nationals at Nottingham. I'm hopeful that this will also be a good valued competitive experience for our members that have entered.

So far we have 100 entry's over all sexes and weapons. We then have an age group competition in Manchester, my focus will swing that way, once the nationals have been completed. I will help the organisers as much as I can to make it a successful competition.

The members seem happy that we are trying as a committee to deliver a quality and well managed set of competitions this season but I would like to add that the social fencing side is also important to our membership.

I'd like to thank all 2020 event managers for there continued effort in delivering a quality product to our membership. The ranking selection system seems to be receiving some criticism. We however must hold firm on our commitment to our membership. In that, if you participate and do well, you could qualify for representation.

Ranking and Selection

Propose that the subcommittee be renamed the Ranking Subcommittee and leave selection as the responsibility of the Selectors.

Ranking is happening; the BVF International and Cambridge Open results have been added to the ranking tables.

The ranking algorithms should be reviewed. There are now several proposals:

- a) EVF (system also up and running): gives points for place, bonus for rounds of DE, bonus for podium, boost for EVF Championships.
- b) GP (3 nominated events) aka the Selection Ranking system
- c) JRM (BVF + international + Open events)
- d) HK (based on Scottish experience)
- e) BD (based on England Fencing Youth ranking)

The issues to revisit are:

- List of events
- Extraction of BVF results from results (eg in an international event)
- Allocation of points (table or algorithm, bonuses and boosts)
- Number of results to make a ranking score
- Whether the ranking system will ever be accepted by the Selectors as a prime source of information
- WHO WILL RUN THE SYSTEM?

Notes for meeting – Data Controller

JRM

Data Controller

I have discussed with MS (by email) the role of Data Controller. We agreed on the current document Data Controller Jrm 15/7/2019.

MS suggested backing up also to the Cloud with a service such as DropBox. This should be actioned.

We should add the key elements of this document to the Job Descriptions.

The outstanding question is who the committee can appoint as Data Controller.

Data Controller

JRM

The DC should ensure that:

- BVF follow the GDPR
- Data is secure and can survive a disaster such as fire at a committee members house
- Data can survive the loss of the Web host
- Data can survive damage by malicious hackers
- Data is distributed under control

GDPR

We should hold minimum data.

We should consider whether parts of the data should be encrypted.

For compliance with the GDPR, data should be deleted when a member dies/resigns/fails to renew – this is not so easy, it would be easy to destroy the integrity of the database if we were to simply delete records. I suggest that we amend the member's record to delete contact details (address, telnums)

Action: **JRM** to add functionality to the Membership program to “delete” old records without compromising data integrity.

Security

Regular scheduled backups of databases to another site or location: A scheduled task backs up the BVF database to my laptop every day. The backup file is then compressed and saved to a network storage device in a different room at home.

Regular backups of web pages to another site or location: This is done infrequently about once a year. The web pages are copied to my laptop and the network storage device.

Control of Distribution

Data is shared with a small number of people eg Winton Team Captains (ca 4 people) and Event Managers (ca 2 people).

All recipients have signed a non-disclosure agreement – the agreements are held by the Secretary in paper form.

The minimum of data is distributed in the form of an Excel spreadsheet and the data is password protected. The password is sent in a separate email.

Chairman’s Report to Committee – January 2020

The BVF International in Guildford was an excellent event and there has been some very good feedback. Thank you to Event Manager, Graham Paul and his team – Marcia Stretch, Alex Savin, Mavis Thornton and Peter Huggins.

It was good to see so many foreign fencers there.

Some important issues for the committee are to consider the way forward with the BVF website, reconsider the eligibility rules for the Age Groups, and decide if the WMO is viable.
