**Minutes of AGM 2013**

**Chairman's Report**

The Chairman read his report to members. He explained the change of date of the Age Group competition to June which will be held at Bletchley. Full details will be circulated in due course.

**Treasurer's Report**

Copies of the accounts have been circulated. The Treasurer presented the accounts and explained that the surplus annual funds would be put into the account for the European Team championships 2016 which we will be hosting. We will also be actively seeking sponsorship for this event. The Treasurer thanked Sonya Mason for all her work on the accounts together with thanks to Diane Austin for auditing the annual accounts. Diane Austin will be standing down from this job in the future so a volunteer is needed to take over. Accounts were accepted unanimously.

**Secretary's Report**

The Secretary read her report giving details of the meetings during the year. Her work mainly consisted of printing and distributing the Newsletter to those members not on-line. She also volunteered to act as co-ordinator for any groups wishing to go to international competitions.

**Membership Secretary's Report**

John Mason said that, at present, membership was 540. 66 members have not renewed. There has been an increase in entries to the national championships. Terry Wishart asked if it was possible to obtain a list of BF members eligible to join the BVF. After discussions with BF it has been agreed that BF will circulate an email to these members on behalf of BVF.

Those members paying by cheque should pay £20.00 annual fee to encourage members to pay by DD. David Sweeney made the point that not everyone has access to the internet. Membership of BF is, however, necessary in order to compete in BVF competitions.

### **Any Other Business**

Booking Procedure for foreign trips: A motion has been proposed by Richard Bonehill, 2<sup>nd</sup> by Jane Hutchison as follows:

“A recent dispute has identified that the current accommodation booking procedure for foreign trips (World and European Championships etc.) is not suitable. The motion is that the Committee investigates the booking procedure and replaces it with one which is not open to misinterpretation by either the participants or the organisers and protects the statutory rights of members of British Veteran Fencing.”

The Chairman stated that this has been discussed in committee. The present system has worked very well over many years. The Committee are in the process of revising the procedure and RB is happy that the Committee are implementing changes to be introduced for the future.

David Sweeney suggested that the changes in booking procedure be circulated to all fencers selected. It was agreed however, that in view of overseas trips being available to all members, the procedures will be published to all members using the Newsletter and website.
