## 24/03 Competitions

# 24/03.1 Guildford 2024 (GP organiser)

Main takeaways from the survey:

- Second hall cold
- Announcements were missed
- Piste numbers should be on screens / paper should also be used
- Runners should check everyone is where they should be
- Date of event cannot be changed due to calendar and availability of venue this needs to be explained
- Start times should remain the same for next year

GP reported he had received two emails concerning the black card issued at Guildford, despite a report having been submitted to British Fencing. It was decided to refer these emails to Caryl Oliver as EVF President.

The BF insurance for foreign fencers needs to be paid at a rate of £3.50 per fencer. PB

## 24/03.2 Nationals 2024 (KA organiser)

#### 24/03.3 Age Groups **2024** (ND organiser)

Leon Paul has confirmed equipment hire.

Venue and armourer secured.

Joe Pearce organising referees, but a local event means that there may be more need for referees to come from afar.

Entry is open and the early closing date has been announced.

#### 23/03.5 **Winton Cup**

### 24/04 **AGM 2024**

The Age Groups give the ideal opportunity for a physical AGM as holding previous AGMs via Zoom had not resulted in a high attendance and was not an easy platform to use for debates.

It was decided to hold the AGM at the Age Groups venue on the Saturday after the fencing has finished (approximately 5pm).

It was decided to hold a Q & A session after the AGM.

#### 24/05 **Selection**

## 24/05.1 Existing World Champion selection

The Committee had decided to allow an existing World Champion to defend their title as long as they competed in at least one qualifying event and at this meeting decided that no particular result would be demanded. This is only for the 2024 season and will be reviewed when the rules are set for 2025. LW to update the website accordingly.

Whilst discussing the World Championships CM informed the Committee that British Fencing would need to levy of £15 per fencer to cover the considerable amount of administration involved in the entry process. This will be added on to the individual fencer's entry fee.

#### 24/05.2 **Selection Error**

There was an error made when the team for the 2023 squad was selected. One fencer dropped out and the replacement fencer selected did not appear to be next in the rankings. This caused understandable upset to the next-ranked fencer. This was a simple error, made

by the Chairman of Selectors under difficult personal circumstances and under great time pressure.

The overlooked fencer received an apology at the time from both the Chair of Selectors and President, but it has come to light that some fencers thought this oversight was deliberate. This is absolutely not the case.

In future, the procedure will be that the weapon selector makes all selection decisions, which are then checked by the other weapon selector and also the Chair of Selectors. As it happens, it turned out at a later date that although an initial error had been made, the correct replacement fencer had in fact been chosen.

# 24/05.3 Automated ranking system

An external automated system has been suggested by a BVF member. The offer was appreciated but, due to technical issues previously explored, the committee decided to keep the system managed internally by the Committee and selectors.

#### 24/05.4 European Teams

If any selector is selected for the European Team, the other weapon selector will make the team selection.

### 24/06 European Veterans Fencing

The committee discussed various issues which have arisen and had the following concerns:

- What is the black card procedure?
- Communication with and between federation reps
- Are they rules or guidelines?
- Communications of rule changes
- Who makes the rules and how are they decided?

The Committee discussed the EVF proposals for outdoor social fencing events. Unfortunately the UK is not ideal for outdoor fencing and the costings unrealistic for the UK, but the committee thought it a very good initiative and hopes it is well supported.

The EVF asked whether European Circuit rankings will be used for GB selection. The committee was not in favour of this suggestion due primarily to costs for fencers in time and money and the difficulty comparing different results in different events. It is possible that the European Individual may be used as a selection event, but this poses problems as it is biannual.

The Committee discussed the issue of Russian fencers being allowed to fence at a recent circuit competition and a Ukrainian fencer scratching from the competition on principle. As far as BVF is aware there is a ban on Russian and Belarusian fencers competing in EVF events as published on the EVF website and the response to the recent situation was poor. GA was asked to write to find out what the rules are on who can compete and how they can be implemented in Circuit events.
